Each tax rate is determined by dividing the amount of revenue required by the current assessed valuation. The result is multiplied by 100 so tax rate will be expressed in cents per \$100 valuation.

ORDINANCE NO. 599

AN ORDINANCE LEVYING A TAX FOR THE YEAR 2022 FOR THE CITY OF META, OSAGE COUNTY, MISSOURI, FOR THE GENERAL REVENUE FUND.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF META, MISSOURI AS FOLLOWS:

Section 1. Whereas and hereby is levied on all real estate situated in the City of Meta, Osage County, Missouri and on all personal property owned by citizens of Meta, Osage county, Missouri, a tax of 0.3978% on each one hundred dollars valuation of each property, as assessed by the Assessor Osage County, Missouri for the year 2022 for municipal purposes.

Section 2. All ordinances or parts of ordinances in conflict with any of the provisions of this ordinance are hereby repealed.

Section 3. This ordinance shall become effective and be in full force from and after its passage and approval.
