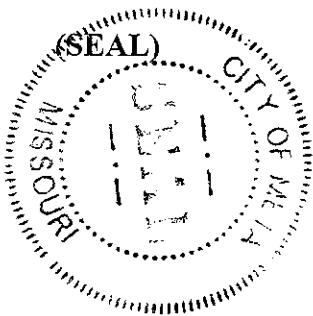
Section 1. The election returns attached hereto are hereby accepted by the City of Meta and made an official part of the records of the City of Meta.

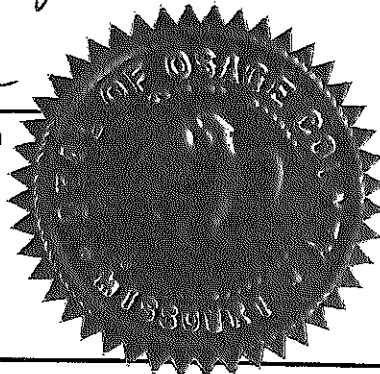
